

ATHLETIC TRANSPORTATION WAIVER FORM

The Martin Luther School Athletic Department states the following: Student Athletes shall be transported to and away from away contests (games and /or scrimmages) by school authorized vehicles only. Under certain circumstances or exceptional situations where it creates an inconvenience to the family, students may be excused from riding back to school from an athletic event on school authorized transportation. Should a parent approach the Head Coach at an away contest and request that their son/daughter ride home with them without advanced written notification, the head coach may agree upon receiving written release on site."
